**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARK COLLATERAL ("Release") is made as of the 29 day of July, 1998, by NATIONSBANK, N.A., formerly known as NATIONSBANK, N.A. (SOUTH), formerly known as NATIONSBANK OF GEORGIA, N.A., a national banking association (the "Lender").

WITNESSETH:

WHEREAS, Acme Boot Company, Inc., a Delaware corporation, successor by merger to Acme Boot Company, Inc., a Tennessee corporation (the "Borrower"), and Lender entered into that certain Financing Agreement, dated December 28, 1993 (as amended, modified or restated through the date hereof, the "Credit Agreement"; capitalized terms used herein and not otherwise defined are used herein as defined in the Credit Agreement);

WHEREAS, Borrower has received from the Lender a full release of the Credit Agreement and all liens and security interests granted, pledged and assigned by the Borrower to the Lender, including, without limitation, that certain Collateral Assignment of Trademarks, Design Patents and Goodwill and License Agreement, dated as of December 28, 1993, by and between the Borrower and the Lender (the "Trademark Security Agreement"); and

WHEREAS, Lender has agreed to further document the release of all liens and security interests granted, pledged and assigned pursuant to the Trademark Security Agreement.

NOW, THEREFORE, in consideration of the premises and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The Lender has released and terminated and does hereby release and terminate all liens and security interests in those certain assets of Borrower which were assigned, pledged and granted to the Lender under and pursuant to the Trademark Security Agreement, including (i) all of the Borrower's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Exhibit A attached hereto, (ii) all of the Borrower's rights, title and interest in and to the United States patents (the "Patents") set forth on Exhibit B attached, in each case together with (iii) all proceeds and products of the Marks and Patents, (iv) the goodwill of the businesses with which the Marks are associated and (v) all causes of action arising prior to or

after the date hereof for infringement of any of the Marks and Patents of unfair competition regarding the same.

2. The Lender agrees to cancel and terminate and does hereby cancel and terminate all rights of the Lender and obligations of the Borrower created solely under the Trademark Security Agreement.

3. This Release shall be governed by and construed in accordance with the laws of the State of New York.

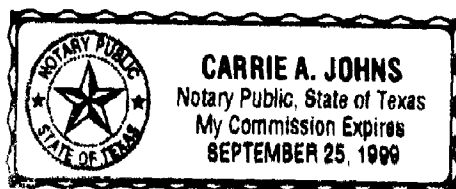
