AMENDMENT OF ARTICLES OF INCORPORATION

BY

CONNECT PUBLIC RELATIONS, INC. (formerly Network Associates Consulting, Inc.)

On the 23rd day of April, 1998, the Board of Directors of Network Associates Consulting, Inc. proposed the following change to the Articles of Incorporation. The proposed change was unanimously accepted by the shareholders of the Corporation with 11,753 shares voting for the amendment and none against. This constitutes all of the outstanding shares and is sufficient for approval of the measure according to the corporate by-laws.

The text of the amendment is as follows:
