

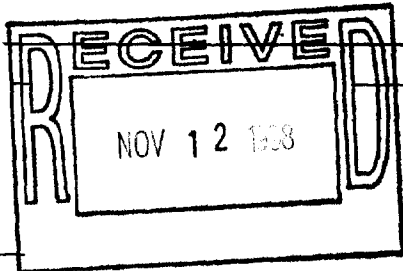

## ASSIGNMENT OF TRADEMARKS


