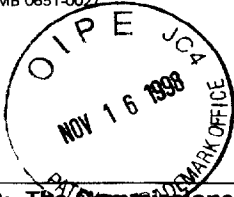

**ASSIGNMENT OF REGISTRATION OF A MARK**


