RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE, dated August 18 1998 granted by LaSalle National Bank ("LaSalle").

W I T N E S S E T H :

WHEREAS, Wace USA, Inc. ("Wace") and LaSalle, have entered into a Trademark Security Agreement, dated as of December 17, 1997, (the "Trademark Security Agreement"), pursuant to which Wace granted to LaSalle a security interest in all of the Trademarks and Licenses (as such terms are defined in the Trademark Security Agreement);
