ASSIGNMENT OF TRADEMARKS

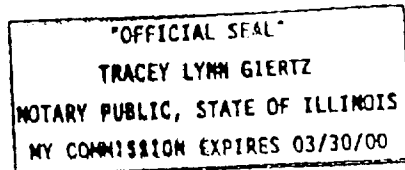

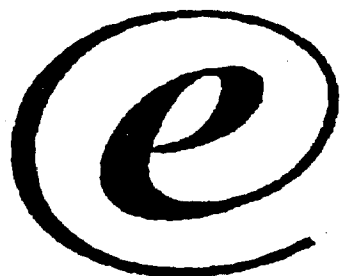
