TRADEMARK ASSIGNMENT

This Assignment is made as of 8/6/98, 1998, by Research Institute for Plastic Cosmetic and Reconstructive Surgery, Inc., a California corporation ("Seller") and Brenda Purdy ("Buyer").

1. **RECITALS.** Buyer and Seller have entered into an Agreement of Purchase and Sale of Assets dated July 10, 1998 (the "Agreement"), pursuant to which Buyer has acquired selected tangible and intangible assets of Seller respecting its business, including, inter alia, the trademarks and trademark registration identified in Exhibit A hereto, incorporated herein by this reference ("Trademarks"). This grant further includes any rights of use including, without limitation, common law rights as may have been acquired by Seller, if any, respecting such Trademarks or marks or symbols confusingly similar to heretofore adopted and/or used by Seller.

3. **FURTHER ASSURANCES.** Seller further agrees to execute all papers thus here in conjunction with said Trademarks identified in Exhibit A hereto and to cooperate with Buyer, its successors, assigns and legal representatives, in obtaining and presenting evidence in connection therewith or in policing or enforcing of the right to transfer hereby.
