Release of Trademark Security Agreement

THIS RELEASE is entered into between **Montreal Trust Company of Canada, as Trustee**, (the "Lender"), with offices at 151 Front Street West, Suite 605, Toronto, Ontario, Canada M5J 2N1, and **Roberts PolyPro, Inc.** (formerly known as Roberts Systems, Inc.), a South Carolina corporation (the "Borrower"), with offices at 8500 South Tryon Street, Charlotte, NC 28273.

Witnesseth:

WHEREAS, Borrower is the owner of the trademarks set forth in Exhibit A attached hereto ("Trademark Rights"); and

WHEREAS, pursuant to a certain Credit Agreement by and between Borrower and Lender, Borrower granted a continuing security interest to Lender in certain assets, including the Trademark Rights; and
