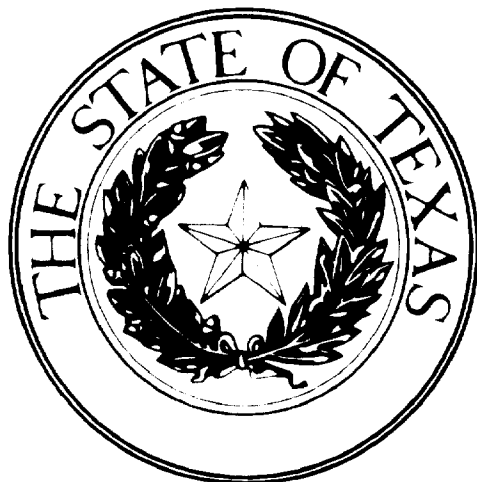

ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF SOUTHWEST TRACK BUILDERS, INC.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is SOUTHWEST TRACK BUILDERS, INC.

ARTICLE TWO

The following amendments to the Articles of Incorporation were unanimously adopted by all of the shareholders of the corporation on July 29, 1991.

The first amendment alters Article I of the original Articles of Incorporation by changing the name of the corporation and the full text of such Article I as amended is as follows:

"Article I

"The name of the corporation is SOUTHWEST RECREATIONAL INDUSTRIES, INC."

The second amendment adds a new Article XI to the original Articles of Incorporation and the full text of such Article XI is as follows:

"Article XI

"A director of the corporation shall not be personally liable to the corporation or its shareholders for monetary damages for an act or omission in such director's capacity as a director, except

for liability for: (1) a breach of a director's duty of loyalty to the corporation or its shareholders; (2) an act or omission not in good faith or that involves intentional misconduct or a knowing violation of the law; (3) a transaction from which a director received an improper benefit, whether or not the benefit resulted from an action taken within the scope of the director's office; (4) an act or omission for which the liability of a director is expressly provided by statute; or (5) an act related to an unlawful stock repurchase or payment of a dividend. If the laws of the State of Texas are hereafter amended to authorize corporate action further eliminating or limiting the personal liability of a director of the corporation, then the liability of a director of the corporation shall thereupon automatically be eliminated or limited to the fullest extent permitted by such laws. Any repeal or modification of this Article XI by the shareholders of the corporation shall not adversely affect any right or protection of a director existing at the time of such repeal or modification with respect to events or circumstances occurring or existing prior to such time."

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was Three Thousand Shares of Common Stock; and the number of shares entitled to vote on the amendment was Three Thousand Shares of Common Stock.


ARTICLE FOUR

The holders of all of the shares outstanding and entitled to vote on the amendment have signed a consent in writing pursuant to Article 9.10 of the Texas Business Corporation Act adopting said amendment and any written notice required by Article 9.10 has been given.
