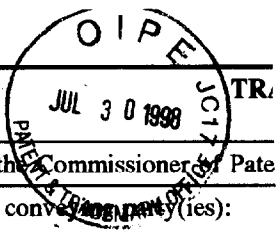

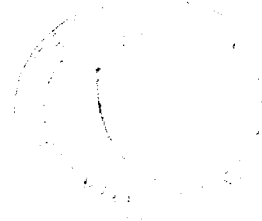

In the notification registered in The Register of Business Enterprises on 20/01/1996, the company changed the enterprise name to LUXO AS.

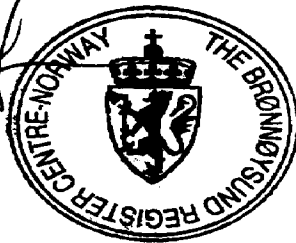
