The following Articles of Merger are filed pursuant to ORS 60.494 by Deschutes River Broadcasting, Inc., an Oregon corporation, the surviving corporation in a merger of Deschutes River Broadcasting of Oregon, Inc., a Oregon corporation and a wholly owned subsidiary of Deschutes River Broadcasting, Inc. with and into Deschutes River Broadcasting, Inc. (the "Subsidiary Merger"), pursuant to ORS 60.491.

1. The name of the parent corporation is Deschutes River Broadcasting, Inc. ("Parent"), an Oregon corporation.
2. The name of the subsidiary corporation is Deschutes River Broadcasting of Oregon, Inc., a Oregon corporation ("Subsidiary"). Parent owns 100% of the 100 outstanding shares of Subsidiary's common stock.
3. The plan of merger is attached hereto as Exhibit A and is incorporated herein by reference.
4. Shareholder approval of the Subsidiary Merger was not required, pursuant to ORS 60.491.
5. The effective date of the Subsidiary Merger shall be December 31, 1996.
