ASSIGNMENT FOR SECURITY

WHEREAS, ASOLO SPA, a corporation of ITALY (the "Assignor"), is the owner of the entire right, title and interest in and to certain trademarks, service marks and tradenames, registrations and pending applications therefor, identified and listed in the annexed Schedule A (the "Trademarks"); and

WHEREAS, the Assignor has requested a loan from DEUTSCHE BANK SPA a corporation of ITALY having an office at Padova, Piazza Alcide De Gasperi 34 (the "Assignee"), and in connection therewith, the Assignor has executed and delivered a Security Agreement on the "Trademarks", in favor of the Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby assign and grant unto the Assignee a security interest in, and mortgage on, all right, title and interest of the Assignor in and to the Trademarks, including the applications therefore, and all the rights and privileges relating thereto, including, without limitation, all royalties for any licenses granted thereon, and any and all causes of action for infringement thereof and the right to the recovery of damages and/or proceeds resulting therefrom (the "Collateral"), to secure the prompt payment of the obligations set forth in the Security Agreement. The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the assignment of and security interest in the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

Upon the full and indefeasible payment of the obligations set forth in the Security Agreement, the Assignee shall assign all of its rights in the Collateral to the Assignor.
