ASSIGNMENT

WHEREAS, General Instrument Corporation (GIC-1) was incorporated as a Delaware corporation on June 12, 1967;

WHEREAS, Jerrold Electronics Corporation merged with and into General Instrument Corporation (GIC-1) on May 30, 1980;

WHEREAS, General Instrument Corporation (GIC-1) by name change on March 26, 1992 became known as GI Corporation;

WHEREAS, GI Corporation by name change on July 22, 1993 became known as General Instrument Corporation of Delaware;

WHEREAS, FLGI Holding Corporation, a Delaware corporation incorporated on June 28, 1990, by name change on March 30, 1992 became known as General Instrument Corporation (GIC-2);

WHEREAS, General Instrument Corporation of Delaware merged with and into General Instrument Corporation (GIC-2) on July 25, 1997, with General Instrument Corporation (GIC-2) being the surviving corporation;

WHEREAS, General Instrument Corporation (GIC-2) by name change on July 21, 1997 (effective July 25, 1997) became known as General Semiconductor, Inc.;

WHEREAS, General Semiconductor, Inc. ("ASSIGNOR"), a Delaware Corporation having its principal place of business at 10 Melville Park Road, Melville, New York 11747, is the owner of U.S. Trademark, Registration No. 1,114,840, registered on March 13, 1979 for the mark STARPACK ("Mark");

WHEREAS, General Instrument Corporation (GIC-3) ("ASSIGNEE"), a Delaware corporation having its principal place of business at 101 Tournament Drive, Horsham, Pennsylvania 19044 desires to

acquire the above registered Mark and all goodwill of the business symbolized thereby; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR hereby assigns to ASSIGNEE all of the right, title, and interest in and to the aforesaid registered Mark and any goodwill of the business symbolized thereby. It is agreed that the ASSIGNOR shall be legally bound upon request from ASSIGNEE to execute all instruments which ASSIGNEE may deem necessary or desirable for securing and maintaining the Mark hereby assigned, all without further compensation to ASSIGNOR.

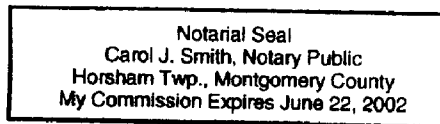
