TRADEMARK ASSIGNMENT AND INDEMNIFICATION

This Trademark Assignment and Indemnification Agreement (the "Agreement") is made as of August 20, 1997, by and between Falcon Products, Inc., a Delaware corporation, doing business at 9387 Dielman Industrial Drive, St. Louis, Missouri 63132 ("Assignor"), L&P Property Management Company, a Delaware corporation, doing business at 4095 Firestone Boulevard, Southgate, California 90280 ("Assignee") and Leggett & Platt, Incorporated, a Missouri corporation, doing business at No. 1 Leggett Road, Carthage, Missouri 64836 ("Leggett & Platt").

WHEREAS, Assignor previously executed on September 8, 1997, an assignment of the trademarks and the United States trademark registrations set forth on Exhibit A hereto (the "Trademarks"), including the goodwill of the business symbolized thereby, effective as of August 20, 1997 to Leggett & Platt Property Management Company, a California corporation ("Assignment I"); and

WHEREAS, Assignee subsequently advised Assignor that the assignee designated in Assignment I does not exist, and that the assignee should have been designated as Assignee identified herein; and

WHEREAS, Assignor, relying on the foregoing representation by Assignee, is willing to execute this Agreement and annul and supercede any effect of Assignment I.




