RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this "Release") is given as of November 13, 1998, by **FINOVA CAPITAL CORPORATION** (formerly known as Greyhound Financial Corporation) ("**Finova**") with respect to the following facts:

WHEREAS, as collateral security for the obligations of Saffola Quality Foods, Inc., a Delaware corporation ("**Saffola**"), under a Loan Agreement between Saffola and Finova (the "**Loan Agreement**"), Saffola granted to Finova a security interest in, among other things, the trademarks of Saffola listed on **Schedule A** attached hereto (the "**Trademark Collateral**") pursuant to a Collateral Assignment of Trademarks and Patents and Security Agreement dated as of February 28, 1991, between Saffola and Finova (the "**Assignment**"), which was recorded with the United States Patent and Trademark Office on March 26, 1991, at Reel 776, Frame 909; and


WHEREAS, the obligations of Saffola to Finova under the Loan Agreement have been satisfied in full and Finova wishes to terminate the Assignment and relinquish and release its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Finova hereby agrees as follows:

1. Finova hereby irrevocably and unconditionally terminates the Assignment and relinquishes and releases any and all rights to and interests in the Trademark Collateral and hereby assigns and reconveys all such rights and interests to Saffola and its successors and assigns.

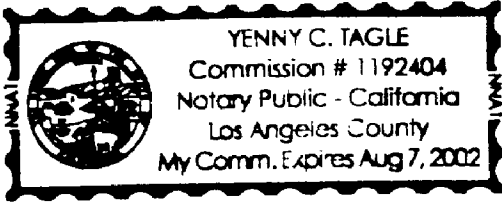
