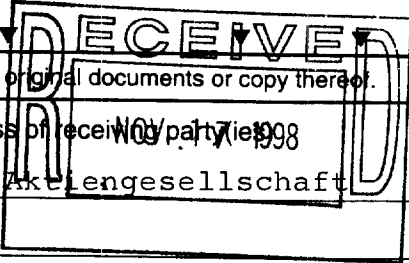




TRADEMARK ASSIGNMENT
