

**DECLARATION**

I, Martin Piccolo, of the City of Mississauga, in the Province of Ontario declare:

1. I am Vice-President of Dynamex Canada Inc., ("Dynamex") and as such have knowledge of the matters set forth in this declaration.
2. Pursuant to an Asset Purchase Agreement ("Agreement") dated May 31, 1995 Dynamex's predecessor in interest Parcelway Courier Systems Canada, Ltd., purchased all of the assets of Dynamex Express Inc., a wholly-owned subsidiary of Air Canada, including all trademarks used in connection with the business being sold. Subsequent to the sale of its business to Dynamex, Dynamex Express Inc., dissolved.
3. On October 10, 1996, Dynamex's predecessor Parcelway Courier Systems Canada Ltd. changed its name to Dynamex Canada Inc. ("Dynamex") pursuant to Articles of Continuance filed on that date.
4. Dynamex has recently been advised by Air Canada that U.S. Registration No. 2,102,561 for the mark STRATEGIC STOCKING LOCATIONS was inadvertently omitted from the schedule of marks attached to the Agreement and should have been included on the schedule pursuant to the terms of the Agreement. Accordingly, Dynamex submits with this Affidavit a recordal cover sheet for the recordal of the assignment of the mark STRATEGIC STOCKING LOCATIONS and corresponding U.S. Registration No. 2,102,561 to Dynamex.
