TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT made May 7, 1998 by Jac Pac Foods, Ltd., a New Hampshire corporation ("Seller"), to Manchester Acquisition Corp., a Delaware corporation ("Purchaser"), pursuant to the Asset Purchase Agreement, dated March 31, 1998 (the "Asset Purchase Agreement"), between Seller and Purchaser.

WHEREAS, Seller has adopted and used in its business the trademarks set forth on the attached Schedule A; and

WHEREAS, Purchaser is desirous of acquiring the trademarks set forth on the attached Schedule A and any registrations thereof and applications therefore (collectively, the "Trademarks").

NOW, THEREFORE, for good and valuable consideration paid by Purchaser to Seller pursuant to the Asset Purchase Agreement at or before the execution and delivery hereof, the receipt and sufficiency of which is hereby acknowledged, Seller does hereby sell, assign, transfer, convey and deliver to Purchaser, its successors and assigns, the Trademarks, together with the goodwill of the business in connection with which the Trademarks are used, all of the foregoing to be held and enjoyed by Purchaser for its own use and for the use of its successors, assigns or other legal representatives, together with all claims for damages by reason of past, present and future infringement of the rights assigned under this Trademark Assignment, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this transfer to Purchaser had not been made.

Seller hereby agrees to execute all such documents as may be required, for each designated jurisdiction, to transfer and record the transfer in each such jurisdiction of any Trademark application or Trademark registration.


Seller hereby appoints and constitutes Purchaser as attorney-in-fact for Seller with respect to the transfer of title of any of the Trademarks. Purchaser's authority hereunder shall include, without limitation, the authority to execute and receive any certificate of ownership or other document to transfer title to any Trademarks, and to take any other actions necessary or incident to the powers granted to Purchaser in this Trademark Assignment.

This instrument shall inure to the benefit of Purchaser and its successors and assigns and shall be binding upon Seller and its successors and assigns.

IN WITNESS WHEREOF, this Trademark Assignment has been duly executed and delivery as of the date first above written.




