

In accordance with Section 17-211(c) of the Delaware Revised Uniform Limited Partnership Act ("DRULPA"), and Sections 263 and 103 of the Delaware General Corporation Law ("DGCL"), the undersigned hereby adopts the following Certificate of Merger:

1. Raytheon Appliances, Inc., a Delaware corporation ("RAI"), is merging with and into Amana Company, L.P., formerly known as RAI Merger Limited Partnership, a Delaware limited partnership ("Partnership") (RAI and Partnership are collectively referred to herein as the "Merging Entity").
