UNITED STATES TRADEMARK ASSIGNMENT

WHEREAS, Concentric Technologies, Inc., a corporation duly organized and existing under the laws of the State of Virginia, hereinafter referred to as "ASSIGNOR," has adopted and used and is the owner of the trademark EMIX (U.S. Reg. ASSIGNOR covenants that ASSIGNOR is the owner of the Mark and the holder of record title to the Registration, and that ASSIGNOR has full power to make this Assignment.
