ASSIGNMENT OF PATENTS AND TRADEMARKS

For One (\$1.00) Dollar and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby absolutely, unconditionally and irrevocably transfers, assigns and sets over to Assignee, all of Assignor's right, title and interest in, to and under the patents and trademarks and/or services together with goodwill or the Business in connection with such marks are used (collectively referred to as "Intellectual Property") identified on Schedule 1.2(a) of the Asset Purchase Agreement.

Assignor agrees to, and hereby does, indemnify, save and hold Assignee harmless of, from and against any and all loss, cost, expense, liability, damage, action, cause of action, demand or claim arising out of or in connection with title and ownership to any of the Intellectual Property accruing prior to the date hereof.

Assignee acknowledges and agrees that all expenses associated with the assignment, transfer and recording of the Intellectual Property shall be shared equally by Assignor and Assignee.

Assignor and Assignee each hereby agree to cooperate in every respect as may be reasonably required by the other party in order to perfect and otherwise fully effectuate the assignments made to Assignee pursuant to the terms and provisions of this Assignment. Without limiting the generality of the foregoing, each party agrees to execute or join with the other party in the other actions reasonably requested by the other party in order to accomplish the aforesaid purposes, and to cooperate with the other party in confirming to any third parties the existence and effectiveness of this Assignment.

This Assignment is provided pursuant and subject to the terms and limitations contained in that certain Asset Purchase Agreement, dated September 30, 1998 (the "Agreement"), between the parties hereto. Capitalized terms not otherwise defined herein shall have the meanings given them in the Agreement. This Assignment shall be governed by, construed and enforced in accordance with the laws of the State of Michigan.

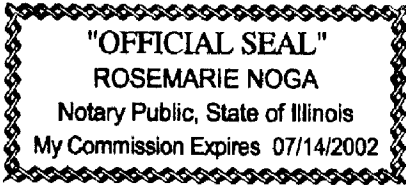

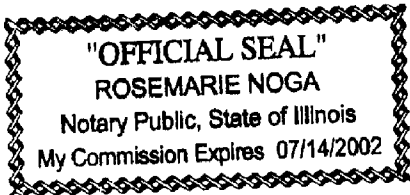


