RESTATED CERTIFICATE OF INCORPORATION

UNIVERSITY PATENTS, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That at a meeting of the Board of Directors of UNIVERSITY PATENTS, INC., resolutions were duly adopted setting forth a proposed amendment to the Restated Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Restated Certificate of Incorporation of this corporation be amended by changing Article FIRST thereof so that, as amended, said Article FIRST shall be and read as follows:


"FIRST: The name of the corporation (hereinafter called the "Corporation") is Competitive Technologies, Inc."
