This RELEASE is given as of this ______ day of November, 1998 by BankBoston, N.A., formerly known as The First National Bank of Boston, a national banking association ("Assignor"), located at 100 Federal Street, Boston, Massachusetts, in favor of New England Patriots, L.P., a Delaware limited partnership ("Assignee"), located at One Boston Place, Boston, Massachusetts 02108.

WHEREAS, pursuant to a Collateral Assignment of Trademarks and Trademark Applications dated February 25, 1994 (the "Security Agreement"), by and between Assignee and Assignor, Assignee collaterally assigned to, and created a security interest in favor of Assignor, with the power of sale to the extent permitted by applicable law and the NFL Constitution, in and to all of Assignee's (a) then owned or existing or thereafter acquired or arising trademarks, trademark applications, service mark, registered service marks and service mark applications including, without limitation, the trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications listed on Schedule A attached hereto, together with any goodwill connected with and symbolized by any such trademarks, trademark applications, service marks, registered service marks, service applications, and (i) all renewals thereof, (ii) all income royalties, damages and payments then and thereafter due and/or payable under and with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, (iii) the right to sue for past, present and future infringements and dilutions thereof, and (iv) all of the Assignee's rights corresponding thereto throughout the world (collectively, the "Trademarks") and (b) rights under or interest in any trademark license agreements or service mark license agreements with any other party, whether the Assignee is a licensee or licensor under any such license agreement, together with any goodwill connected with and symbolized by any such trademark license agreements or service mark license agreements, and the right to prepare for sale and sell any and all assets then or thereafter owned by the Assignee and then or thereafter covered by such license (collectively, the "Licenses"), which security interest was recorded in the United States Patent and Trademark Office on March 8, 1994 at Reel 1116/Frame 0191:

WHEREAS, pursuant to a First Amendment to Collateral Assignment of Trademarks and Trademark Applications dated as of July 8, 1994 (the "Amended Security Agreement"), by and between Assignee and Assignor, Assignee ratified and reaffirmed the Security Agreement obligations of Assignee to Assignor, which security interest was recorded in the United States Patent and Trademark Office on December 5, 1994 at Reel 1258/Frame 0147;

WHEREAS, pursuant to a Third Amendment to Collateral Assignment of Trademarks and Trademark Applications dated as of July 8, 1994 (the "Third Amended Security Agreement"), by and between Assignee and Assignor, Assignee ratified and reaffirmed the Security Agreement obligations of Assignee to Assignor, which security interest was recorded in the United States Patent and Trademark Office on December 13, 1996 at Reel 1538/Frame 0141;

WHEREAS, the Assignee has fully satisfied all of its obligations under the above referenced security agreements and Assignor desires to release its security interest in and the collateral assignment of the Trademarks and the Licenses.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in and the collateral assignment of the Trademarks and Licenses and reassigns any and all interest that it may have in the Trademarks and Licenses to Assignee.


