This RELEASE is given as of this 10th day of November 1998 by Citibank, N.A., a national banking association ("Assignor"), located at 339 Park Avenue, New York, New York 10043, in favor of Kansas City Chiefs Football Club, Inc., a Texas corporation ("Assignee"), located at One Arrowhead Drive, Kansas City, Missouri 64129.

WHEREAS, pursuant to an Amended and Restated Security Agreement dated as of October 31, 1996 (the "Restated Security Agreement"), by and between Assignee and Assignor, as administrative agent for the lenders referenced therein, Assignee assigned (effective immediately upon acceleration of any of the Secured Obligations after the occurrence of an Event of Default but subject to the terms of the NFL Letter Agreement as provided in Section 9(a) of the Restated Security Agreement, each as defined in the Restated Security Agreement), and granted a continuing security interest in and continuing lien upon, a number of the Trademarks which security interest was recorded in the United States Patent and Trademark Office on December 18, 1996 at Reel 1526/Frame 0574; and

WHEREAS, Assignee has fully satisfied all of its obligations under the above referenced security agreements and Assignor desires to release its security interest in and continuing lien upon the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in and continuing lien upon the Trademarks and reassigns any and all interest that it may have in the Trademarks to Assignee.
