This RELEASE is given as of this 10th day of November 1998 by Citibank, N.A., a national banking association ("Assignor"), located at 339 Park Avenue, New York, New York 10043, in favor of Buccaneers Limited Partnership, formerly known as Tampa Bay Area NFL Football, Inc., a Delaware limited partnership ("Assignee"), located at One Buccaneer Place, Tampa, Florida 33607.
