1. The service mark registrations and applications and the associated service marks (the "Marks") listed on Exhibit A attached hereto and made a part hereof;
2. All accounts, accounts receivable and proceeds now existing or hereafter arising out of or in connection with the exploitation of the Marks and/or any element thereof and/or any rights derived therefrom; and
3. All now existing or hereafter arising instruments, contract rights, general intangibles (including, without limitation, trademark rights), documents, chattel paper and all other intangible personal property of any kind and description relating to the Marks.

The foregoing assignment shall constitute a Security Interest.

This Trademark Collateral Assignment and Security Agreement is being entered into in order to secure the obligations of Court TV pursuant to that certain Letter Agreement between Court TV and Lifetime, dated October 23, 1998, with respect to Lifetime's sublicensing to Court TV certain telecast rights to the television series entitled "Homicide: Life On The Street."
