ASSIGNMENT OF TRADEMARKS

And Assignor does hereby covenant and agree, for itself and its successors and assigns, that it will execute and deliver to Assignee any and all additional documents and perform any further acts necessary to vest in Assignee the rights hereby conveyed without expense to itself.
