IN WITNESS WHEREOF, said Rojina Cisneros has caused this trademark assignment to be executed this 15 day of October, 1998.

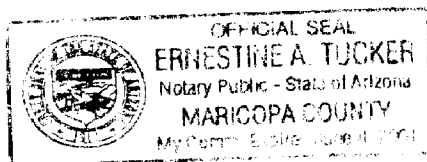
