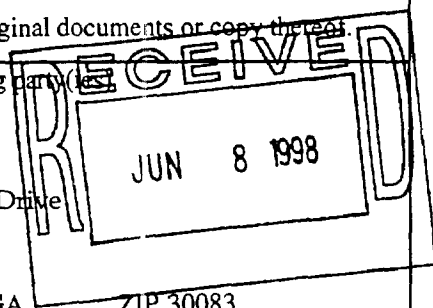

ASSIGNMENT NUNC PRO TUNC

WHEREAS, **Thermo Pac Associates, Ltd.**, a Georgia general partnership now dissolved and formerly having a mailing address at 1609 Stone Ridge Drive, Stone Mountain, Georgia, 30083 is the record owner of a certain mark which is registered in the U.S. Patent & Trademark Office, namely: U.S. Trademark Registration No. 1,750,287 for the mark SQUEEZERS; and

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, **Thermo Pac**

Associates, Ltd. does assign, convey, and transfer unto Thermo Pac, Inc. the entire right, title, and interest in and to said marks and the said registrations thereof, including the right to sue for damages and other remedies in respect of any infringement of the mark which may have occurred before the effective date of this assignment, together with the goodwill of the business symbolized by said marks. This Assignment is expressly made NUNC PRO TUNC, this Assignment to have the same legal force and effect as if executed on December 31, 1992.
