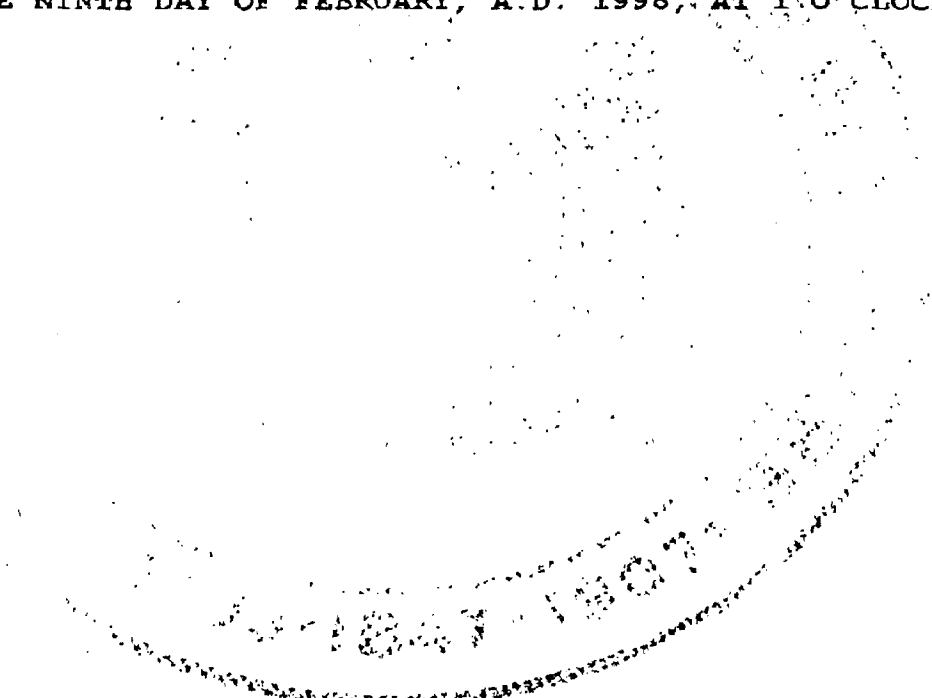

1. The name of the corporation is Brown-Bridge Industries, Inc. (the "Corporation").
2. This Certificate of Amendment sets forth certain an amendment to the Certificate of Incorporation of the Corporation, which was duly adopted by the Board of Directors of the Corporation and by the written consent of the holders of a majority of each class of stock of the Corporation entitled to vote thereon in accordance with Sections 141 and 242 of the General Corporation law of the State of Delaware.

"ARTICLE I


The name of the Corporation is Spinnaker Coating, Inc."
