WHEREAS, as of August 15, 1984, American Seating Company ("ASSIGNOR"), a corporation organized under the laws of Delaware, having its principal business in Champaign, Illinois, had adopted and was using the trademark "E-Z-Fold" and design in its business of selling basketball backstops, which mark is registered in the United States Patent and Trademark Office, Registration No. 716,795, dated June 13, 1961; and

WHEREAS, Uni-Weld Basketball Backstops Company, Inc., now known as Progressive Athletics, Inc. ("ASSIGNEE"), a corporation organized under the laws of Ohio, having its principal place of business address at State Route 60 South, Beverly, Ohio 45715, purchased said mark and the registration thereof pursuant to an Asset Sale Agreement entered into between ASSIGNOR and ASSIGNEE, dated August 15, 1984;

WHEREAS, due to an oversight by the parties, the assignment of said mark and the registration thereof was not recorded with the United States Patent and Trademark Office at the time of its sale;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby assign unto the said ASSIGNEE, its successor and assigns, effective as of August 15, 1984, all rights, title and interest in and to the said mark, together with the good will of the business symbolized by the mark, and the above identified registration thereof.

IN WITNESS WHEREOF, ASSIGNOR has caused this document to be duly and legally executed and delivered on this 23rd day of Nov, 1998.


