## ORDER APPROVING SALE OF PERSONAL PROPERTY FREE AND CLEAR OF LIENS AND ENCUMBRANCES (SALE NO. 1)

THIS MATTER comes on for consideration upon the Trustee's Motion for Approval of Sale of Personal Property Free and Clear of Liens and Encumbrances (Sale No. 1). The Court, having reviewed the Motion, the file and being fully advised in the premises, finds and orders as follows:

- 1. The Debtor filed his Voluntary Petition under Chapter 11 of the Bankruptcy Code February 25, 1994. The case was converted to one under Chapter 7 on or about March 3, 1995, and the undersigned is the duly appointed and acting Trustee.
- 2. The Debtor scheduled as assets herein Patent No. 502806 issued July 2, 1991, on a folding step; and Patent No. S-M07/959, 693 filed November 13, 1992, on a self-draining planter. The Debtor's schedules indicate foreign patents are pending for each of the above patents and that trademark applications are pending for each patent.
- 3. The Debtor asserted an exemption to the foregoing items of property to which the Trustee filed his objection.
- 4. The Trustee has received an offer from Step N Seat, Inc., to purchase all patents and trademarks of the Debtor in this case including, but not limited to, the above for a total purchase price of \$5,000.00. The Trustee has received an earnest money deposit of \$500.00 from Step N Seat, Inc.
- 5. The Trustee proposed to sell the patents and trademarks, along with any other patents or trademarks owned by the Debtor, to Step N Seat, Inc., for the sum of \$5,000.00.
- 6. To the best of Trustee's knowledge, information and belief, there are no liens or encumbrances against the subject property.

- 7. The proposed sale shall be free and clear of all liens and encumbrances with liens and encumbrances, if any, to attach to the sale proceeds.
