TRADEMARK
DISCHARGE AND RELEASE OF SECURITY INTEREST

WHITE SYSTEMS, INC. (formerly White Storage & Retrieval Systems, Inc.), a New Jersey corporation having a place of business at 30 Boright Avenue, Kenilworth, New Jersey 07033; ALVEY SYSTEMS, INC., a Delaware corporation having a place of business at 9301 Olive Boulevard, St. Louis, Missouri 63132; THE BUSCHMAN COMPANY, an Ohio corporation having a place of business at 10045 International Boulevard, Cincinnati, Ohio 45246; and BUSSE BROS., INC., a Wisconsin corporation having a place of business at 124 N. Columbus Street, Randolph, Wisconsin 53956 (collectively "Debtors");

and

NATIONSBANK, N.A., a national banking association having a place of business at Independence Center, 15th Floor, 101 N. Tryon Street, Charlotte, North Carolina 28255 ("Secured Party");

entered into a certain Security Agreement recorded in the Trademark Title Records of the U.S. Patent and Trademark Office on March 5, 1996 at Reel 1404, Frames 0524 et seq. to secure certain obligations of the Debtors to the Secured Party and pursuant to which the Debtors granted certain rights, in and to Trademark Registration Nos. 1,896,824 for the mark LIGHT CARPET and 1,099,578 for the mark AISLE-SAVER (collectively "Trademarks").

The Debtors and the Secured Party have agreed to discharge and release the Trademarks from the lien created by the Security Agreement. Accordingly, for good and valuable consideration (receipt of which is hereby acknowledged), and in accordance with clause 24 of the Security Agreement, the Secured Party hereby discharges and releases the Debtors of the Secured Party's right, title and security interest in and to the Trademarks and the registrations thereon, and any and all rights held or could be held by the Secured Party by virtue of the Security Agreement as to said Trademark and trademark registrations thereon.

The Secured Party acknowledges that the execution of this instrument is for recording the present discharge and release by the Secured Party to the Debtors and on the due recording thereof in the U.S. Patent and Trademark Office, at the expense of the Debtors, the Security Agreement is deemed to be terminated and discharged between the parties as to said trademarks and trademark registrations thereon.

The Secured Party agrees, at the sole cost and expense of the Debtors, to execute, acknowledge and deliver any further instruments and documents and to take all such further actions or to comply with any applicable Federal or State Laws which may be

necessary or appropriate in order to carry out the intentions and purposes of the discharge of the Security Agreement as to said Trademarks and trademark registrations thereon.

IN WITNESS WHEREOF, the Secured Party has caused this Discharge and Release of Security Interest to be executed by its duly authorized officer at the place and on the day and date indicated.

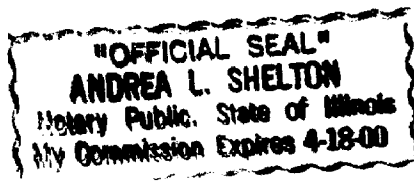
