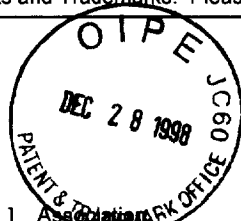


ASSIGNMENT OF REGISTRATION
