**RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT
AND SECURITY AGREEMENT**

Release of Trademark Collateral Assignment and Security Agreement (the "Agreement") is made, executed and delivered as of December 10th, 1998 by and between **RONDELE FOODS, LLC**, a Delaware limited liability company with its principal business located at 8100 Highway K South, Merrill, Wisconsin 54452 (along with its successors and assigns, hereafter collectively referred to as "Borrower"), and **ASSOCIATED BANK**, a Wisconsin banking association, with an office located at 303 S. First Avenue, Wausau, Wisconsin 54401 (along with its successors and assigns, hereafter collectively referred to as "Lender").

WITNESSETH

WHEREAS, Borrower and Lender entered into a certain Trademark Collateral Assignment and Security Agreement dated January 16, 1996 (the "Assignment"); and

WHEREAS, Borrower has entered into a certain Asset Purchase Agreement dated as of November 25, 1998 with Rondele Acquisition, LLC (the "Asset Purchase"), pursuant to which Borrower will be assigning all of its right, title and interest in the Trademarks (as defined in the Assignment) identified in and subject to the Assignment; and

WHEREAS, certain obligations of Borrower to Lender shall be satisfied from the proceeds of the sale under the Asset Purchase.

NOW, THEREFORE, for and in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases the Trademarks from the Assignment.


