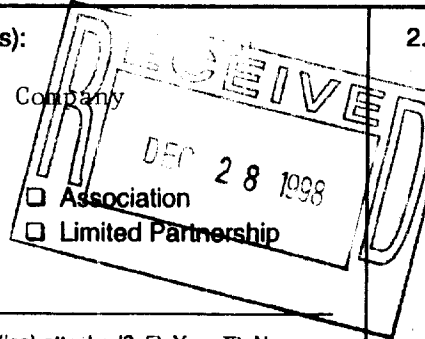

ASSIGNMENT OF UNITED STATES TRADEMARK RIGHTS


