## ASSIGNMENT OF TRADEMARKS



NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, PRADCO, by these presents does sell, assign and transfer unto the said EBSCO all of its right, title and interest in and to the said trademark described above, together with the goodwill of the business symbolized by said trademark and registration thereof. the same to be held and enjoyed by the said EBSCO, for its own use and benefit and that of its successors, assigns and legal representatives, to the full end of the term for which said trademark are granted, as fully and entirely as the same would have been held had this assignment and sale not been made, together with all claims for damages by reason of past infringement of said trademark, with the right to sue for and collect the same for its own use and for the use of its successors, assigns or other legal representatives, subject to the rights of any licensees under any existing license agreements to which PRADCO is a party or to the obligations under which EBSCO may have succeeded or to which its right in said trademark is subject and subject further to any obligations to said licensees which PRADCO may have; and said PRADCO does hereby covenant and agree with the said EBSCO to execute and deliver such other and further instruments and take such other and further actions as may be necessary or appropriate to transfer said trademark, claims for damages by reason of past infringement and right to sue and collect therefor to EBSCO.
