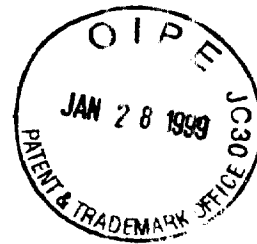

RELEASE OF SECURITY INTEREST



WHEREAS, SPORTS & RECREATION, INC. (now known as JUMBOSPORTS INC.) granted BARNETT BANK N.A. (formerly known as BARNETT BANK OF TAMPA), as Collateral Agent for certain institutional lenders (the "Agent"), a lien on and a security interest in and to the trademarks identified in Exhibit A attached hereto and by this reference made a part hereof (the "Trademarks"), pursuant to a Security Agreement dated June 4, 1996 (the "Security Agreement");

WHEREAS, notice of the Security Agreement was recorded with the United States Patent and Trademark Office on June 11, 1996 at Trademark Reel 1444, Frame 0826;

WHEREAS, the Agent desires to cancel and terminate all of its liens and security interests on or against the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the Agent hereby releases unto SPORTS & RECREATION, INC. (now known as JUMBOSPORTS INC.), effective as of the date hereof, any lien or security interest in and to the Trademarks and any trademark applications appearing on Exhibit A, and any foreign trademarks or applications as set out in the schedules to the Security Agreement, together with the goodwill associated with the foregoing, all books and records relating to the Trademarks or products involving the Trademarks, and any and all proceeds thereof, and any interest ever possessed by the Agent in any claims by SPORTS & RECREATION, INC. (now known as JUMBOSPORTS INC.) against third parties for infringement of the Trademarks and the proceeds therefrom and licensing royalties.
