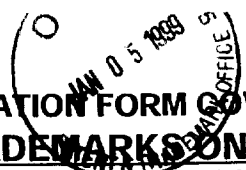



ASSIGNMENT AGREEMENT --
U.S. MARKS AND COPYRIGHTS

This Assignment Agreement ("Agreement"), effective as of December 30, 1998, is entered into by and between **ATLANTA COMMITTEE FOR THE OLYMPIC GAMES, INC.**, a Georgia non-profit corporation, having its principal place of business at 250 Williams Street, Atlanta, Georgia 30303 ("ACOG"), and the **UNITED STATES OLYMPIC COMMITTEE**, a Congressionally-chartered non-profit corporation, having its principal place of business at One Olympic Plaza, Colorado Springs, Colorado 80909 ("USOC").

WHEREAS, ACOG was and is the Organizing Committee for the 1996 Olympic Games; and

WHEREAS, USOC is the National Olympic Committee for the United States; and

WHEREAS, ACOG has adopted, used and/or applied for registration of certain trademarks and service marks, and has registered or applied to register the marks in the United States Patent and Trademark Office as more specifically identified and shown in Exhibit "A" hereto, and in the State of Georgia as more specifically identified and shown in Exhibit "B" hereto (all marks shown in Exhibits A and B hereto are hereinafter collectively referred to as the "Marks"); and

WHEREAS, ACOG has adopted, used and/or applied for registration of certain Copyrights as more specifically identified and shown in Exhibit "C" hereto (the "Copyrights"); and

WHEREAS, ACOG has adopted and used certain other intellectual property not set forth in Exhibits A, B and C, including but not limited to intellectual property associated with certain software, films, videos and photographs, music, pictorial and graphic and sculptural works, literary works and mailing lists (the "Common Law and Other Intellectual Property"); and

WHEREAS, ACOG is in the process of dissolving, in accordance with the Olympic Charter which governs all entities that participate in the Olympic movement; and

WHEREAS, in connection with its dissolution, ACOG has agreed to assign to USOC, as the successor to the business of ACOG, the Marks, the Copyrights and the Common Law and Other Intellectual Property; and

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

ACOG hereby assigns and transfers to USOC, as the successor to the business of ACOG, all right, title and interest in the United States in and to the Marks, the registrations and the applications therefor, the Copyrights and the Common Law and Other Intellectual Property and each of them, together with the goodwill of the business in connection with which the Marks, the Copyrights and the Common Law and Other Intellectual Property are used.

ACOG further assigns and transfers to USOC, as successor to the business of ACOG, all causes of action related to the Marks, the Copyrights and the Common Law and Other Intellectual Property, including but not limited to the right to sue for past infringements, as well as for unfair competition, passing off and any other related causes of action pertaining to the Marks, the Copyrights and the Common Law and Other Intellectual Property.

As to the federal trademark and service mark applications identified in Exhibit "A," the Commissioner of Patents and Trademarks is requested to issue certificates of registration on the applications to USOC.

To effectuate the intent and purpose of this Agreement, ACOG agrees to cooperate with USOC and to forward all pertinent files for the Marks, the Copyrights and the Common Law and Other Intellectual Property to USOC's trademark counsel within thirty (30) days of the execution hereof. ACOG further agrees to execute such further documents as may be necessary to record these assignments with the U.S. Patent and Trademark Office, the U.S. Copyright Office and the State of Georgia.

IN WITNESS WHEREOF, the parties have hereunto set their hands and seals, as indicated below, effective as of the 30th day of December, 1998.
