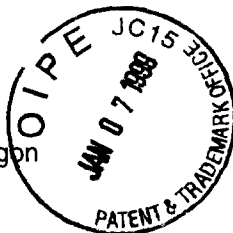

ARTICLE 1

The name of the corporation is PACE Company.

ARTICLE 2

Article 1 of the Articles of Incorporation is hereby deleted in its entirety and shall be replaced by the following:

"Article 1

The name of the corporation is CLEANPAK International, Inc."

ARTICLE 3

This Amendment does not provide for an exchange, reclassification or cancellation of issued shares.

ARTICLE 4

This Amendment was adopted by the Board of Directors and shareholder of the Corporation effective March 31, 1997.

ARTICLE 5

This Amendment was adopted by the Board of Directors and unanimously approved by the shareholder. The shareholder holds 170 shares of the authorized common stock of the Corporation and 40 shares of the authorized preferred stock of the Corporation.


