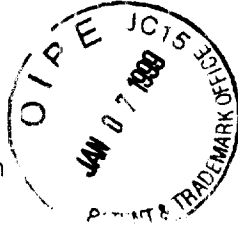

BROD & McCLUNG-PACE CO., an Oregon corporation (the "Corporation"), has adopted the following Articles of Amendment to its Articles of Incorporation:

ARTICLE 1

The name of the corporation is Brod & McClung-Pace Co.

ARTICLE 2

Article 1 of the Articles of Incorporation is hereby deleted in its entirety and shall be replaced by the following:

"Article 1

The name of the corporation is PACE Company."

ARTICLE 3

This Amendment does not provide for an exchange, reclassification or cancellation of issued shares.


ARTICLE 4
