TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made as of the 20th day of November, 1998 by Kerry Inc., a Delaware corporation ("Assignor").

WHEREAS, Assignor has entered into an Asset Purchase Agreement, dated as of November 11, 1998 (the "Agreement"), between Assignor and Hobart Corporation ("Assignee"), a Delaware corporation located at 701 Ridge Ave., Troy, Ohio, 45374-001, pursuant to which Assignor has agreed to sell and Assignee has agreed to purchase certain Intellectual Property (as defined in Section 2.1(c) of the Agreement); and

Assignor hereby requests the Commissioner of Patents and Trademarks to record Assignee, as assignee of the U.S. trademark registrations and applications for registration listed on Schedule A, for the sole use and enjoyment of Assignee, its successors, legal representatives and assigns.
