CHRISTOPHER mark and the registration thereof, together with a one-half undivided interest in the goodwill of the business symbolized by the J. CHRISTOPHER mark and the registration thereof; and

WHEREAS, the Eagle's Eye desires to assign and transfer to Value City the aforesaid one-half undivided right, title and interest.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Eagle's Eye does hereby assign and transfer to Value City a one-half, undivided right, title and interest in and to the J. CHRISTOPHER mark and Registration No. 1,428,449, together with a one-half, undivided interest in the goodwill of the business symbolized by the J. CHRISTOPHER mark and the registration thereof, the same to be held and

enjoyed by Value City, its successors and assigns, to the full end of the term for which the J.

CHRISTOPHER mark is registered and any renewal of the term thereof.

Eagle's Eye hereby covenants that, at the time of execution and delivery of these presents, Eagle's Eye is the sole and lawful owner of the entire right, title and interest in and to the said registration and believes it is the sole and lawful owner of the entire right, title and interest to the J. CHRISTOPHER mark and said goodwill associated therewith and that the same are unencumbered and that Eagle's Eye has good and full right and lawful authority to sell and convey the same in the manner herein set forth.
