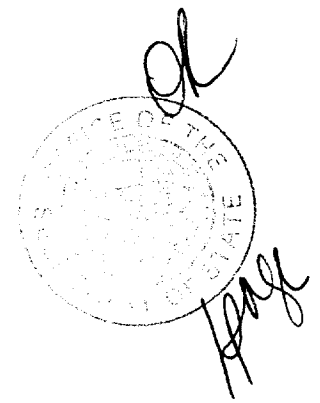



2. Article I of the Articles of Incorporation of the Company is hereby amended to read in its entirety as follows:


"The name of this Corporation is Online Anywhere"
