REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Agreement is made as of this 29 day of December, 1998 by Coast Business Credit®, a Division of Southern Pacific Bank, a California corporation ("Coast"), with offices at 12121 Wilshire Blvd., Ste. 1111, Los Angeles, California 90025, based on, inter alia, the following:

RECITALS

- A. On or about October 28, 1997, Coast and CollecTech Systems, Inc. ("CollecTech") entered into a Loan and Security Agreement ("Loan Agreement") whereby Coast agreed to loan monies to CollecTech
- B. In order to induce Coast to enter into the Loan Agreement, CollecTech entered into a Patent and Trademark Security Agreement dated as of October 28, 1997, recorded on Reel/Frame 1654/0054 on November 14, 1997, in the United States Patent and Trademark Office, granting to Coast a security interest in and to certain intellectual property then owned and thereafter acquired by CollecTech.
- C. Specifically, CollecTech granted a security interest and assigned certain rights in and to the trademarks know as a) CollecTech Systems, Registration Date November 3, 1992, and Registration No. 1729831, and b) Receivables Management Institute, Registration Date April 22, 1997, and Registration No. 2054330 (collectively, "Trademarks").

AGREEMENT

Based on good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Coast hereby releases its security interest in the Trademarks and reassigns to CollecTech, without warranty or recourse, all interests of Coast in and to the Trademarks.


