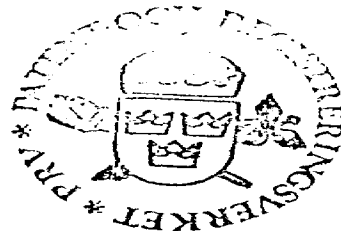
On 6th October, 1989, the Court gave its permission for the fusion agreement to be executed. The company is thus dissolved and has merged into:
