RELEASE OF
TRADEMARK SECURITY AGREEMENTS

This Release dated as of December 1, 1998 (the "Release") is made by Chemical Bank, as Agent for certain Lenders ("Chemical Bank") for the benefit of Stant Corporation (the "Corporation") and the Collateral Grantors pursuant to that certain Amended and Restated Trademark Security Agreement dated as of July 28, 1993 (the "Amended Security Agreement") made by the Corporation, as Borrower, and the Collateral Grantors to Chemical Bank and recorded in the United States Patent and Trademark Office on August 18, 1993 in Reel No. 1019 at Frame No. 423 and that certain Trademark Security Agreement dated as of October 17, 1991 (the "Original Security Agreement") made by the Corporation, as Borrower, and the the Collateral Grantors to Chemical Bank and recorded in the United States Patent and Trademark Office on October 17, 1991 in Reel No. 5872 at Frame No. 754.

Chemical Bank hereby releases all of the Collateral pledged under the Amended Security Agreement and any Collateral remaining under the Original Security Agreement. The Collateral to be released includes but is not limited to all right, title, interest and privileges in, to and under the Trademarks and the Licenses

Each of the parties hereto hereby agrees to take or cause to be taken such further actions, to execute, deliver and file or cause to be executed, delivered, and filed such further documents and instruments, as may be necessary or as may be reasonably requested in order to fully effectuate the intent of this Release.

Any capitalized term not otherwise defined herein shall have the meaning ascribed thereto in the Security Agreement.
