



## ASSIGNMENT

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, ASSIGNOR hereby acknowledges that it has sold, assigned, transferred and conveyed and hereby sells, assigns, transfers and conveys to ASSIGNEE *nunc pro tunc* as of November 22, 1996, all rights, title and interest in and to, and to the use of, the trademark NIKE & Swoosh Design, the goodwill symbolized thereby, and United States Trademark Registration No. 2,104,329 of said mark, free and clear of all liens and encumbrances, together with the right to recover for past acts of infringement of said trademark.

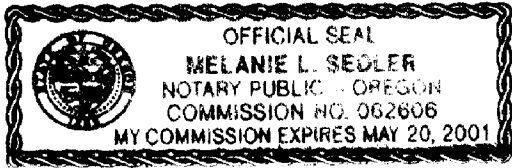
