CRANE CO., a corporation organized and existing under the laws of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That this Corporation was incorporated on the 3rd day of April, 1985, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this Corporation owns all of the outstanding shares of the common stock of POLYVEND, INC., a corporation incorporated on the 23rd day of April, 1970, pursuant to the Arkansas Business Corporation Act.

THIRD: That this Corporation, by the following resolutions of its Board of Directors, duly adopted at a meeting held on October 29, 1997, determined to and did merge into itself POLYVEND, INC.:

RESOLVED, that it is in the best interests of the Corporation to merge Polyvend, Inc., an Arkansas corporation which is a wholly owned subsidiary of the Corporation, with and into the Corporation.

FURTHER RESOLVED, that the Corporation merge, and it does hereby merge into itself Polyvend, Inc., an Arkansas corporation, and assumes all of its obligations within this Corporation as the surviving corporation in such merger.

FURTHER RESOLVED, that the aforesaid merger shall be effective on October 31, 1997.

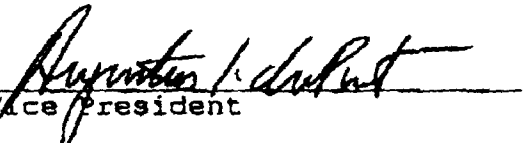
