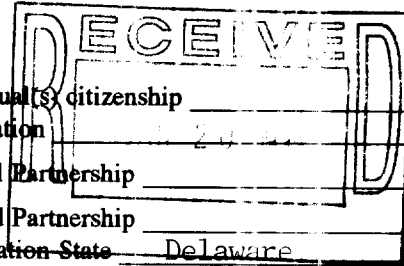

**DOES HEREBY CERTIFY:**

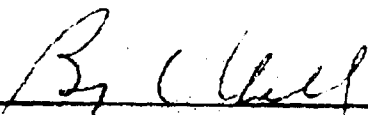
